EXCELSIOR EQUESTRIAN CENTER (“Excelsior”) RELEASE, WAIVER, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT (“Agreement”)

I, as a rider, auditor, spectator, groom, volunteer, sponsor, trainer, or other attendee of this event (“Participant” or “I”), on my own behalf (or if as the Parent/Legal Guardian of a minor Participant), understand the risks of engaging in equine activities, including: (i) the propensity of an equine to behave in dangerous ways that may result in injury to the Participant; (ii) the inability to predict an equine’s reaction to sound, movements, objects, persons, or animals; and (iii) the hazards of surface or subsurface conditions. I agree at all times to be responsible for my personal safety, remain financially responsible for my medical expenses, and waive my right to any claim against Excelsior, its sponsors, instructors, and /or auditors, officers, boarders, employees, volunteers, other members or competition management., arising from my participation in, or observation of, the equine activity. I agree to release, hold harmless, and indemnify Excelsior for any illness, injury, death, damage, cost, or other loss incurred whether by a dangerous latent condition, negligence, or otherwise.

By signing below, I certify that I have read this entire Agreement, acknowledge that the proper Warning Sign has been posted and understand, agree, and intend to be bound by all the terms and conditions contained in the Excelsior Equestrian Center Release, Waiver, Hold Harmless, and Indemnification Agreement.

I further represent that I and the horse entered are eligible as entered. I also agree to be bound by the rules of the competition.
